

# 2016-17 SePRO Golf Pinnacle Program



## Program Qualifications:

Purchase a minimum \$2,500 of any combination of SePRO PGRs and Aquatic Solution Bundles between **October 1, 2016** and **January 31, 2017**.

## Base Rebate Percentage:

Qualifying purchases include SePRO PGRs and Aquatic Solution Bundles. Use the chart on the opposite page to determine your base rebate percentage.



## Aquatic Solution Bundles:
