## How to qualify

Yearlong rebate on qualifying purchases between October 1, 2018 and September 30, 2019. The EDI (or invoices, if required) must be dated within the defined purchase period. **The Early Order Period is October 1, 2018 - December 31, 2018.**

## How to submit

1. Go to POMRewardClub.com, pick your distributor(s), complete your rebate form.
2. Submit your rebate form.
3. If you purchase from a Corteva direct distributor, we will use EDI to validate your claim. If not, you will be directed how to proceed to receive your rebate.

*You may select to have your rebate check directly or as a credit on your account with your participating distributor of your choice.*

## The power of MORE™ reward club

The power is in your hands to earn MORE! Bonuses will be awarded based on your total rebate amount. Please refer to the bonus rebate table below to see the bonus possibilities.

For example, if your total rebate based on your purchases was \$5,000, you would earn a 15% bonus on top of your \$5,000 rebate. **That's an additional \$750 for a total rebate of \$5,750.**

When you qualify for a bonus, this will be included in your rebate check. So, if you submit multiple claims, your bonus will account for previous purchases.

Purchase the equivalent Dimension specialty herbicide on fertilizer, Dimension Ultra 40WP, or Dimension 2EW equal to or greater than 0.25 pounds a.i. per acre (1 pint per acre or higher), equal to the number of treated acres of Defendor specialty herbicide purchased. Rebate is paid on Defendor purchases only. In order to receive this additional rebate amount, you must submit both your Defendor and Dimension 2EW purchases at the same time.

(i.e. 1 quart of Defendor equals 8 acres treated at 4oz. per acre. Therefore, if you were buying a 50 lb bag of fertilizer with a Dimension load rate of 0.21% a.i., you would need to purchase at least 19 bags per 1 quart of Defendor).

One pint of Dimension equals 0.25 pounds a.i. per acre. Dimension 2EW product sizes included are the 0.5 gal, 2.5 gal, and 30 gal. Dimension 2EW bulk or the Dimension + Defendor Value Pak are not included in the quantities for the matching, nor included in this additional rebate payout.
